

Key Initiatives of CCPI-STEM

CCPI-STEM initiative focuses on advancing STEM workforce education, and promoting the NSF Advanced Technological Education (ATE) program

- Establishment of community college
 Regional Networks for advancing STEM workforce education and encouraging academic and business partnerships
 - Development of NSF ATE instructional modules for inclusion in community college leadership graduate programs and leadership institutes
 - CCPI-STEM Fellows Program
 - Dissemination: National, Regional, Local levels
 - e.g., CCPI-casts & Presidents' Press
